Welcome to Wulf Crest Farm's Equestrian Program

Our program blends a passion for classical equitation with a hands-on approach to horsemanship, offering a comprehensive equestrian experience in the heart of Northern Virginia. Established in 2021, our mission is to cultivate confident, competitive, and well-rounded riders, while ensuring that the journey is both enjoyable and rewarding.

Our dedicated team is committed to developing riders of all levels—from beginners mastering the fundamentals to experienced competitors aiming for success in the show ring. We specialize in Hunters, Jumpers, and Equitation, and our instructors believe in teaching from the ground up, highlighting the importance of horsemanship as a foundation for all riding. We emphasize solid fundamentals, safety, and correct technique, helping riders achieve their goals.

Our inclusive community fosters a supportive environment where both juniors and adults can refine their skills, expand their knowledge, and build lasting connections.

New Students

To get started, we'll schedule a one-hour **Introductory Lesson (\$100)**. This gives us a chance to learn more about you, your riding experience, and your goals, while giving you an opportunity to get to know our barn and lesson program.

The session includes a tour of the barn, time grooming and tacking so we can get a sense of your horsemanship experience, and time in the saddle. Afterward, we'll recommend the instructor and lesson format that will be the best fit for you.

Minimum Age: Riders must be at least 8 years old to participate in Wulf Crest Farm's lesson program. This age requirement helps ensure that students have the physical strength, coordination, attention span, and ability to follow safety instructions necessary to participate safely and independently in riding lessons.

New Student Horsemanship Assessment

All new students will begin with an assessment period to ensure they have the basic horsemanship skills needed to participate safely and independently in our regular lesson program.

Before moving into a group lesson or 30-minute private lesson, riders must demonstrate proficiency in a checklist of basic skills, including:

- Safely approaching, haltering, and handling a horse
- Proper grooming
- Tacking and untacking
- Basic tack care and proper equipment storage
- Understanding barn and arena safety procedures
- Following Wulf Crest's turnout and horse-handling procedures

The number of assessment lessons needed will vary based on each rider's prior experience and ability to demonstrate these skills safely and independently. Once the checklist is completed, the instructor will determine when the rider is ready to transition into a group or 30-minute private lesson.

Riding Attire

All riders are required to wear an ASTM/SEI-approved helmet.

For your evaluation lesson, all new students are required to have their own helmet to ensure a proper fit. Please wear hard-soled boots with a heel for your lesson. If you decide to continue with lessons, you will need to purchase paddock boots or tall boots for safety and comfort.

To purchase a helmet, riding boots, or any other riding apparel we recommend [Another Turn Tack Shop](#) in Purcellville VA, which also offers gently used riding gear.

Lesson Payment Policies

We offer three pricing options for lessons: Standard, Certified and Senior Level instruction. Standard and Certified Level instruction is offered in both private and group formats. Please refer to Payment Policies and Terms for detailed pricing information.

Lesson Cancellation Policy

While we understand that illness and emergencies can arise, we maintain a 24-hour cancellation policy to ensure the smooth operation of our lesson program. Both a horse and instructor are reserved for each lesson, and as such, we require at least 24 hours' notice for cancellations.

- If 24 hours' notice is provided, you are eligible to reschedule a makeup lesson.
 - Cancellations made with less than 24 hours' notice will not be eligible for a makeup lesson.

Make-Up Lessons

- **Senior-Level Lessons:** Makeup lessons can be scheduled within the same month or the following month.
 - **Standard and Certified Level Lessons:** Makeup lessons can be scheduled within three months from the start of a lesson package.
 - Makeup lessons will be scheduled at the discretion of the barn, and while we will make every effort to accommodate makeup lessons, we cannot guarantee multiple makeup lessons at the end of the expiration period.

Lesson Schedule (current students)

Please plan to arrive 30 minutes prior to your lesson time to groom and tack your horse. The only exception to this rule is for beginner riders still learning the grooming and tacking process, as this will be incorporated into your lesson time. Horse assignments will be available on the [live lesson calendar](#) a couple hours prior to your scheduled lesson time. Plan on staying 30 minutes after your lesson to have time to properly untack, groom, and cool out your horse.

If you are enrolled in a group lesson, and only 1 rider is present for the day, the lesson will be automatically shortened to a 30 minute private lesson.

Tack and Grooming

Before your lesson, collect all necessary tack (saddle, half pad, schooling pad, girth, bridle) and place it in the grooming stall. Each horse has their own specific tack! Groom your horse thoroughly before and after the lesson. Coats should be curried (curry brush), followed by a hard brush then a soft brush. Manes and tails should be brushed as well as feet picked out (hoof pick).

After your lesson, repeat all grooming steps. All lesson tack should be returned to the tack room, with saddles (stirrups up), half pads, and girths placed on the assigned saddle rack,

and schooling saddle pads placed on the designated shelf. If a saddle pad is dirty or sweaty, kindly place it to dry on the middle drying rack in the tack room. Bits should be rinsed in the sink, wiped off with a clean towel, and put back on their hooks. Please ensure that the grooming stall is swept after your lesson. Brooms, muck buckets, and shovels are provided.

Most horses should be turned out in the appropriate field unless they have another lesson scheduled later in the day. Please refer to the turnout chart at the barn exit to the fields. If your horse was wearing a blanket when you retrieved it from the stall, ensure that the blanket is properly placed back on the horse after your lesson. If you are unsure how to properly place a blanket, please ask your instructor for assistance.

Lesson Structure

Once riders have demonstrated the ability to groom and tack up independently, they are expected to enter the ring fully prepared and ready to mount their horse. This includes ensuring that all preliminary tasks, such as adjusting stirrups, are completed *before* entering the ring. Doing so not only keeps the lesson running smoothly, but also maintains safety and respect for fellow riders and instructors.

Before mounting, every rider must perform a thorough safety check of their tack. This includes:

- Ensuring the girth is properly tightened (a loose girth can be very dangerous).
- Checking that the bridle is correctly fitted and secure.

While riders are responsible for this initial check, our instructors will always perform a final safety inspection of the tack before the lesson starts.

Once mounted, riders should begin by walking their horse around the ring to allow for a proper warm-up. This helps loosen the horse's muscles, focus its attention, and prepare both horse and rider for the lesson ahead.

When the lesson begins, the instructor will call out instructions and guide the rider or group through the planned exercises. If a rider is jumping, the second half of the lesson typically involves jump work, progressing through poles, grids, or full courses depending on ability and focus for the day. However, please note that some lessons may focus entirely on flat work, such as improving balance, position, transitions, and communication with the horse. Every lesson is tailored to the needs and progress of the riders and their horses!

Please note that, on occasion, lessons may be conducted “on the ground” to focus on foundational horsemanship skills, including horse handling, grooming, and safety practices.

Benefits of Horseback Riding

Horseback riding offers a unique combination of physical, mental, and emotional benefits for humans. Physically, it enhances balance, coordination, core strength, and posture as riders must engage multiple muscle groups to communicate with and stay aligned on the horse. Mentally, it promotes focus, discipline, and stress relief, as the rider must remain present and attuned to the horse's movements and behavior. Emotionally, horseback riding nurtures a deep sense of connection and trust between human and animal, which can boost confidence, reduce anxiety, and support emotional healing. For many, the experience of working with horses becomes a powerful form of therapy and personal growth.

Payment Policies and Terms

How Packages Work

- 10-lesson packages are purchased for a specific lesson instructor tier and are valid for 10 lessons or 3 months, whichever comes first. Your package rate is determined by the instructor's tier — Certified Instructor or Instructor.
- The package expiration date is 3 months from the date of the first lesson. For example, if the first lesson is June 7, 2026, the first package is valid from June 7, 2026 through September 7, 2026. The second 10-lesson package would then begin on September 7, 2026 and be valid through December 7, 2026.
- Packages are automatically renewed for another 10 lessons, unless written notice is provided to the Billing Coordinator before the expiration date.
- The Senior Instructor package is purchased on a monthly, ongoing basis rather than as a 10-lesson package.
- Ride with more instructors from different tiers? Simply purchase a package with each instructor you ride with — each package is tracked independently, with its own lesson count and expiration date. Example: lessons with both Emily and Vicki mean two separate packages running side by side.

Substitute Instructors

- On occasion, your regularly scheduled instructor may be unavailable and your lesson may be covered by another staff instructor. Covered lessons count toward your package as usual, at no change in price.
- Our live Google Calendar is the official source for instructor availability and coverage and is updated to show when an instructor is unavailable and who will be providing coverage. **Riders are responsible for reviewing the calendar and noting any instructor substitutions for their scheduled lessons.**
- If you prefer not to have a lesson covered by another instructor, you are responsible for notifying the Lesson Coordinator in advance so the lesson can be rescheduled with your regular instructor, subject to availability.

Single-Lesson (Drop-In) Rate

Interested in trying a lesson with a new instructor before committing to a full package? A single trial lesson is available at the prorated package rate and may be purchased for a one-time lesson. If you wish to continue taking lessons with that instructor, a 10-lesson package must be purchased; ongoing lessons may not be booked at the single-lesson rate.

Cancellation & Makeup Policy

- 24-hour notice is required, by contacting the lesson coordinator via text (571-699-9943) or email (info@wcfstables.com). Notification via your instructor alone is not sufficient.
- Cancellations with 24 hours' notice are eligible for a makeup lesson. Riders are expected to track their own makeup lessons; makeups are subject to scheduling availability, so plan ahead.
- 10-Lesson Package makeups: must be used within 3 months or forfeited. Riders who cancel more than 25% of scheduled private lessons will not be eligible to purchase a new package.
- Monthly Package makeups: must be used within the same or following month, or forfeited.
- Lesson packages and prepaid monthly plans are non-refundable; there are no invoice adjustments for missed lessons.

Boarding & Extra Services Payments

- Board: invoiced on the 25th, due by the 1st.
- Show fees: due within 10 days of invoice.
- Late fee: 5% on invoices 15+ days overdue.
- Overdue payments: if unpaid after 15 days, the balance will be charged to the card on file, including the late fee.

Payment Methods

- Lessons & show fees: Zelle, ACH, credit card, or personal check.
- Board: Zelle, ACH, or personal check (no credit cards).
- All clients are required to keep an active credit card on file.

Supplies: Hay and feed are included at no extra cost. Shavings are invoiced based on the number of bales utilized.

GENERAL USE RELEASE

WITNESS THIS RELEASE dated this ____ day of _____, 20____, by and between **The Stables at Wulf Crest Farm LLC**, hereinafter referred to as **Management**, and _____,

hereinafter referred to as **User**, and, if User is a minor, User's parent or guardian, _____.

For consideration received, and in return for the use, today and on all future dates of the property, facilities and services of Management, Management's instructors, employees, drivers and agents; User, User's heirs, assigns, and representatives, hereby agree as follows:

1. Inherent Risks and Assumption of Risk. The undersigned acknowledges there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equines reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participants ability.

User acknowledges that horses, by their very nature are unpredictable and subject to animal whim. User assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising therefrom. User agrees to abide by and follow Manager's rules and regulations which shall be posted and/or available from time to time. User further acknowledges that the behavior of any animal is contingent to some extent upon the ability of User. User assumes all risks therefore and warrants a full and fair disclosure of Rider's abilities has been made to Manager.

User expressly releases Management from any and all claims for personal injury or property damage, even if caused by negligence (if allowed by the laws of this State) by Management or its representatives, agents or employees.

Warning

1. Under Virginia Law, an equine activity sponsor or an equine professional shall not be liable for an injury to or death of a participant engaged in an equine activity resulting from the inherent risks of equine activities pursuant to Va. Code Ann. §3.1-796.132.

2. User agrees to assume any and all risks involved in or arising out of User's use of any equipment or livestock pertaining to the rental of horses or taking of riding lessons, the use of any arena on the premises of Management and for purposes of taking riding lessons either on the premises or lessons given off the premises by Management personnel.

3. USER (OR USERS PARENT OR GUARDIAN IF USER IS A MINOR) AGREES TO HOLD HARMLESS, INDEMNIFY AND DEFEND MANAGEMENT AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, DAMAGES, JUDGMENTS, ORDERS, COSTS OR EXPENSES, INCLUDING ATTORNEY'S FEES, WHICH MAY IN ANY WAY ARISE FROM OR BE IN ANY WAY CONNECTED WITH USER'S USE OF OR PRESENCE UPON THE PROPERTY OF MANAGEMENT AND THE FACILITIES LOCATED THEREON. In the event User is a minor, the parent or guardian shall further indemnify, defend and hold Management harmless from any such claims by said minor child.

4. In the event User is using User's own horse, or a horse(s) not owned by Management, User warrants said horse(s) shall be free from infection, contagious or transmittable diseases. Management reserves the right to refuse access or use of any horse upon the premises that does not appear to Management to be in good health, or is deemed dangerous or undesirable.

5. Any action brought under this agreement shall be brought within one (1) year of the incident or accident giving rise to said claim. User agrees that damages shall be limited to \$250 for property damage, actual expenses incurred, and a maximum of \$10,000 for non-consequential damages such as pain and suffering.

6. User agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.

Safety Rules

1. No running in the barn/around the horses.
2. No screaming, as it can startle the horses.
3. Always speak to your horse before approaching or touching him. Some horses are likely to jump and may kick when startled.
4. Always approach your horse from the front. If he's turned away from you, call to him or entice him with a treat to get him to come to you. Never approach your horse directly from the rear.
5. Pet a horse by first placing a hand on its shoulder or neck. The touch should be a rubbing action.
6. If he is tied, get him to look at you. Always notice a horse's expression before advancing.
7. When working around your horse, wear boots or hard-toed shoes to protect your feet. Never wear tennis shoes, moccasins or go barefoot.
8. When working around your horse, tie him securely with a quick-release knot, or have someone hold him with a lead rope. Use cross-ties when possible, but be sure they have panic snaps or are secured with a breakable tie, such as baling twine.
9. Always work close to your horse. If you are near his shoulder, you won't be struck with the full force of his feet, nor will you receive the full force of a kick if you stay close to the body when you work about the haunches or pass behind your horse.
10. Never stand directly behind a horse or directly in front of him.
11. Be calm, confident, and collected around horses. A nervous handler can make a nervous horse.
12. Do not drop grooming tools under foot while grooming. Place them where you will not trip on them and the horse will not step on them.
13. If the halter is too loose, the horse may catch a foot in it, especially if he is trying to scratch his head with a hind foot. A loose halter may catch on fence posts or other pasture objects.

14. When leading your horse, walk beside him—not ahead or behind. A position even with the horse's head or halfway between the horse's head and its shoulder is considered safest.

15. Always turn the horse away from you when releasing to turn-out.

16. It is customary to lead from the left (near side), using the right hand to hold the lead, near the halter. The excess portion of the lead should be folded, figure-eight style. When leading, extend your right elbow slightly toward the horse. If the horse makes contact with you, its shoulder will hit your elbow first and move you away from it. Your elbow can also be used in the horse's neck to keep the head and neck straight as well as to prevent the horse from crowding you. A horse should be workable from both sides, even for mounting and dismounting.

17. Never wrap the lead shank or reins around your hand, wrist, or body. Never drape a lead shank or reins across your shoulders or neck.

18. Don't wear jewelry around horses. Rings can cut deeply into fingers, and bracelets can get caught in reins or lead lines. Dangling earrings are particularly dangerous.

19. Be extremely cautious when leading a horse through a narrow opening, such as a door. Be certain you have firm control and step through first. Step through quickly and get to one side to avoid being crowded.

20. At any time you are dismounted or leading the horse, the stirrup irons on an English saddle should be run up or dressed. Be cautious of the stirrups of a Western saddle, which can catch on objects.

21. Never tie your horse by the reins as he may pull back and break the reins or injure his mouth. Always use a halter.

22. When riding, wear boots with proper heels to prevent your feet from slipping through the stirrups.

23. Always wear protective headgear, properly fitted and fastened.
